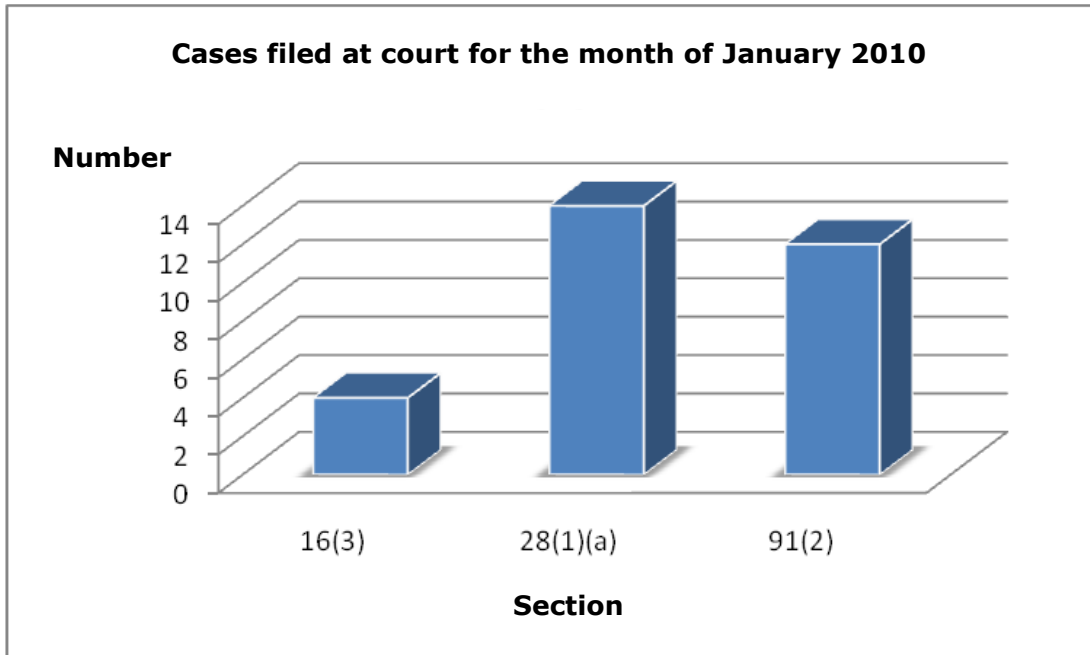

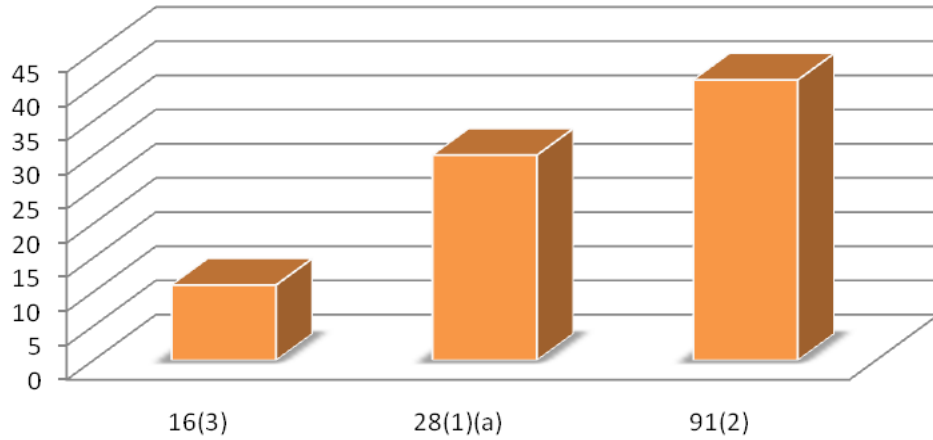

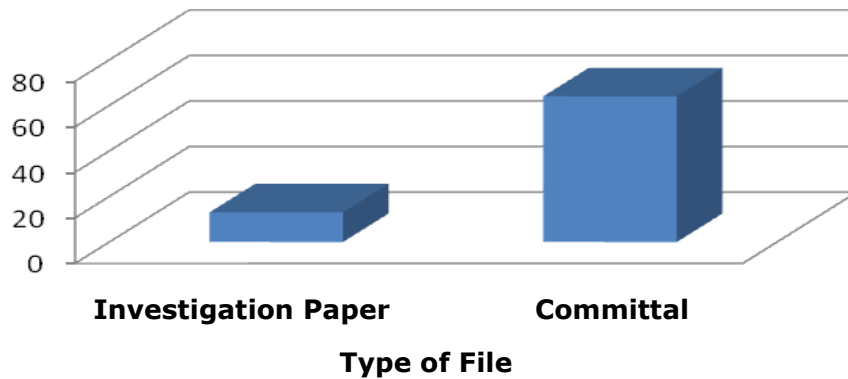
Cases Prosecuted for the month of January 2010

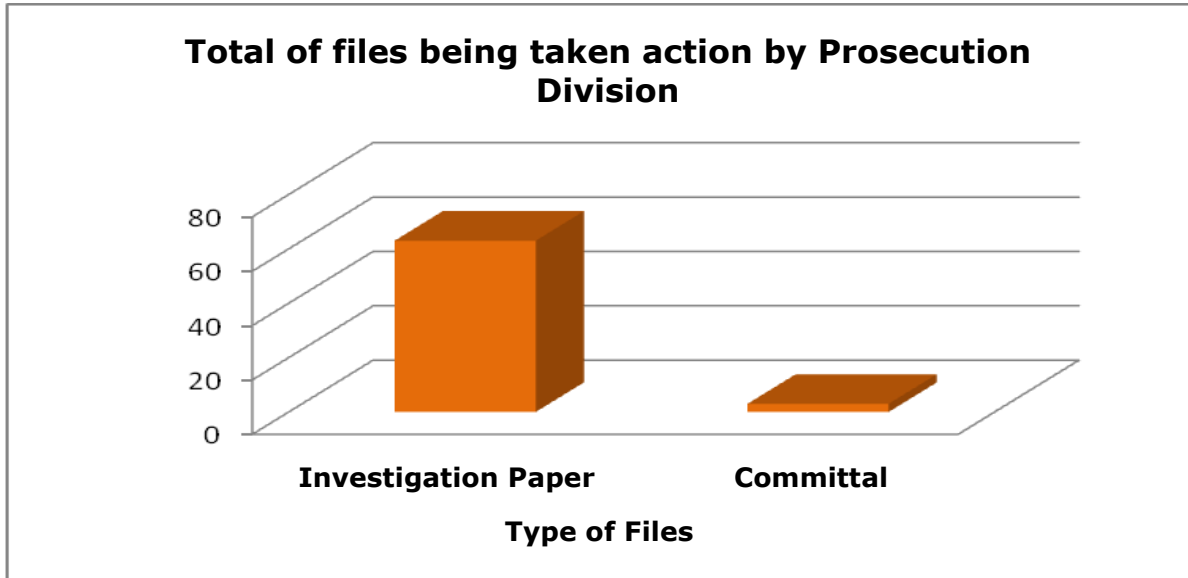

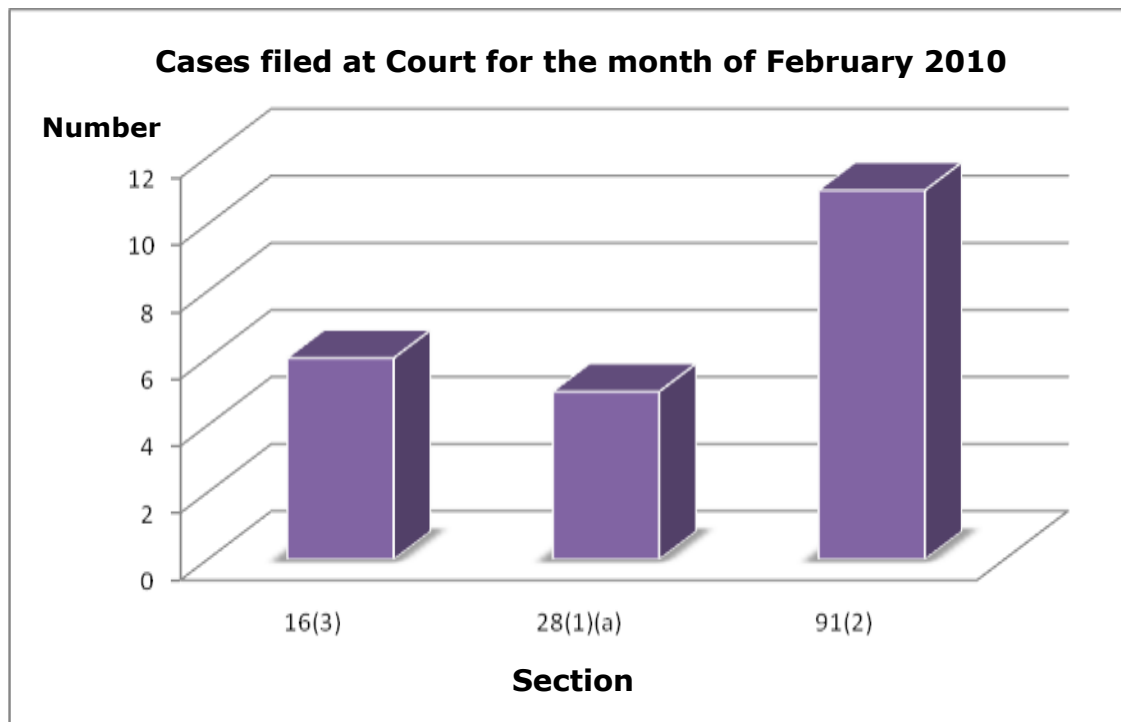

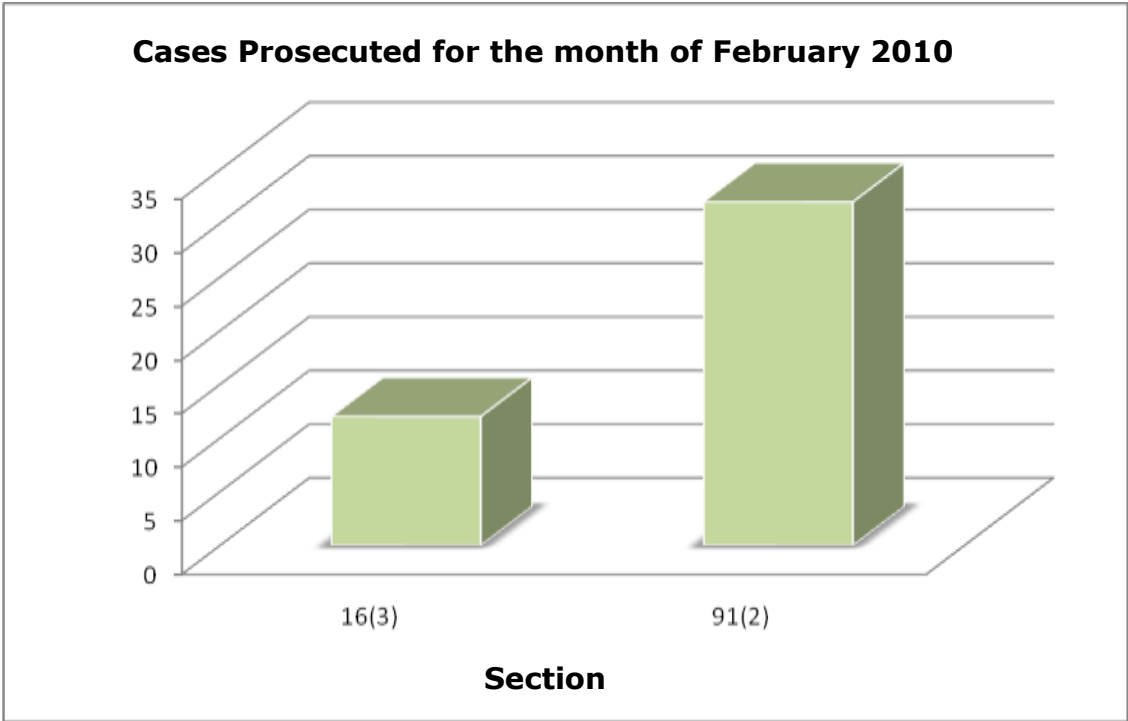

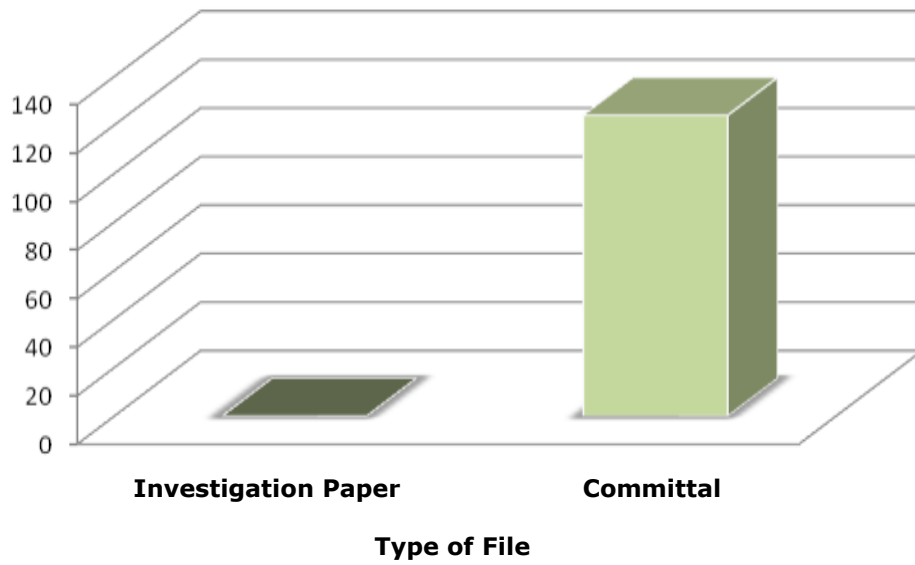

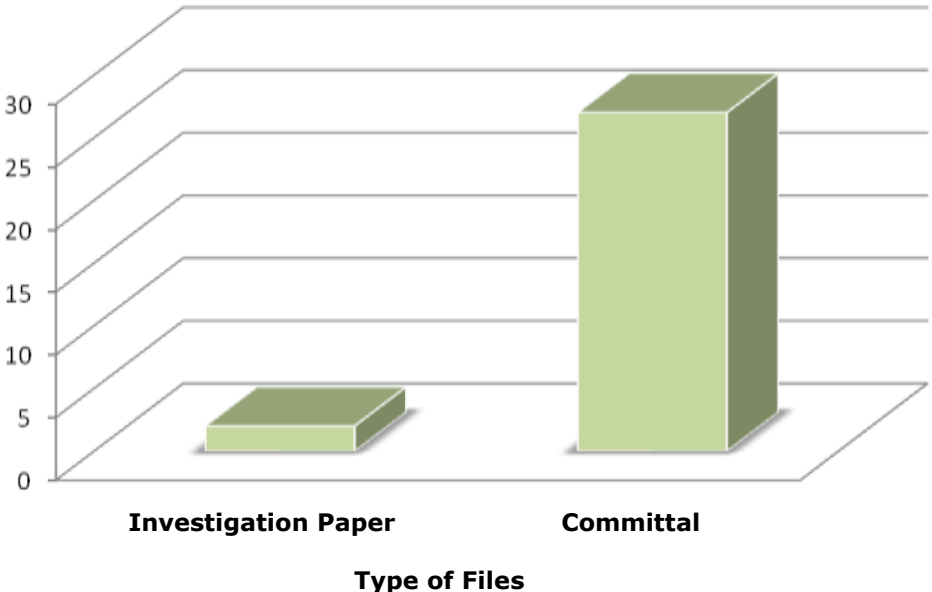

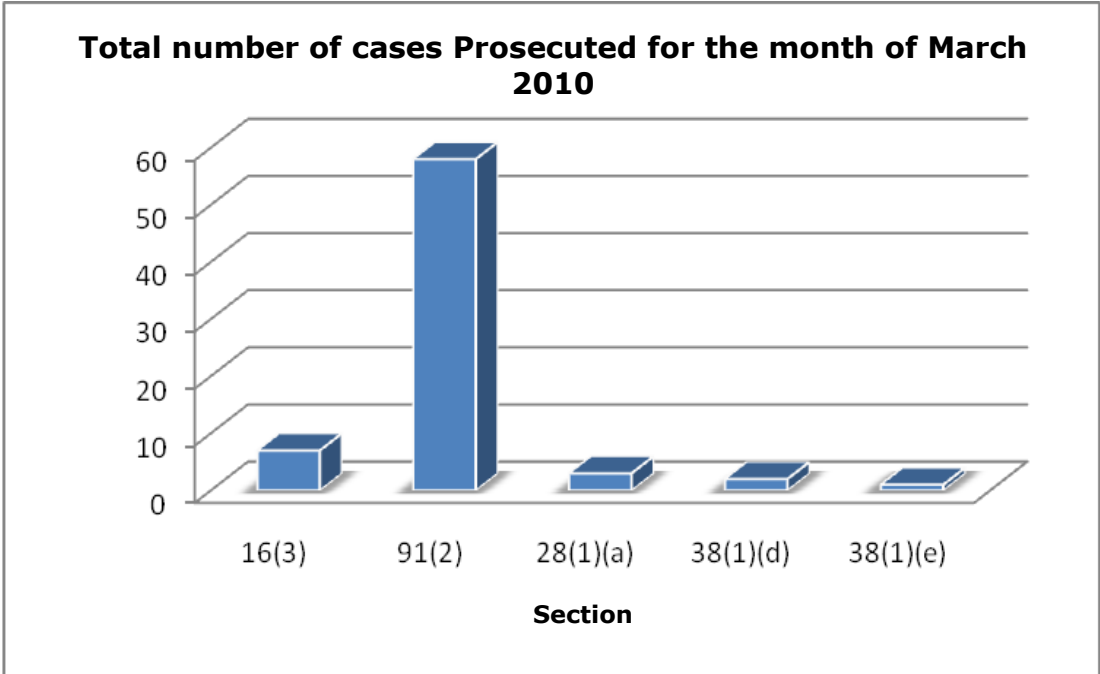

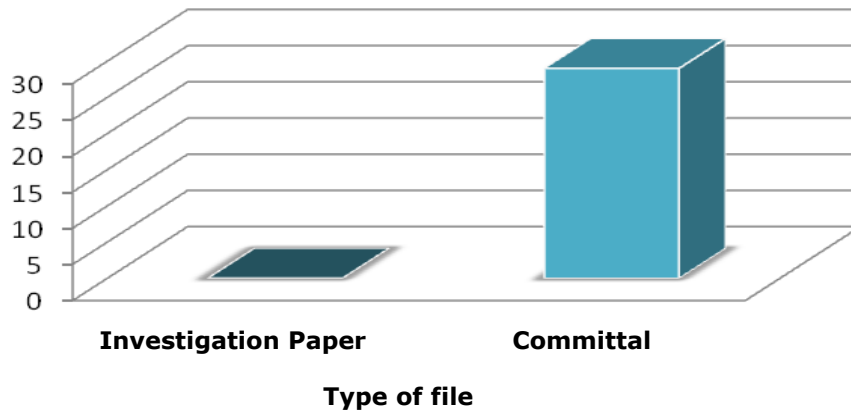
